San Francisco's energy future, the health of San Francisco Bay and electing a new City Attorney are the key issues this November. The best thing you can do for our urban environment is to vote.

During our ongoing energy crisis, it's clear that we cannot trust PG&E to invest in renewable energy or to protect consumer interests. We can put San Francisco in the forefront of solar power development by passing Propositions B and H. Voters also have a chance to establish a public power agency in San Francisco—the Sierra Club and Greenpeace strongly recommend voting Yes on F and I.

- ◆ The Sierra Club has not endorsed in the races for City Attorney, Treasurer, and MUD Ward 4 & has taken no position on Propositions A & G.

Yes on A

Proposition A will allow City College to continue to provide quality educational services for all San Franciscans. Prop A funds will be used to renovate aging facilities, improve access for disabled students and faculty, seismically upgrade classrooms and laboratories at the Evans Campus, complete the computer network and develop new campuses in the Mission and Chinatown/North Beach. Vote Yes on Proposition A.



Yes on B

Proposition B would provide \$100 million to increase San Francisco's energy supply with clean and dependable new sources of electricity generation—such as solar panels and wind turbines. The bond will pay for itself entirely with energy savings, and will not cost taxpayers one dime. Prop B is an important step to reduce air pollution help fight global warming. see: www.votesolar.org

Yes on D

San Francisco Bay isn't what it used to be. Development has shrunk the Bay one-third in size. 95% of its tidal wetlands have been destroyed. Over 100 species of Bay fish and wildlife are extinct, endangered or threatened.



Prop D protects the Bay by requiring voter approval for city-sponsored development projects that would destroy 100 or more acres of the Bay. And it protects the public by ensuring that it's the voters, not political appointees, who make the final decision on this vital issue. See: www.bayvotesyes.org



Yes on F

Prop F will replace the City's Public Utilities Commission with a Municipal Water and Power Agency whose goals will include developing renewable energy programs including solar and wind power, closing the polluting Potrero and Hunters Point power plants and replacing San Francisco's aging water and sewer infrastructure.

Yes on H

Prop H allows San Francisco to finance energy conservation and renewable energy programs—at no risk to taxpayers—with the use of revenue bonds. Unlike general obligation bonds, revenue bonds cannot increase taxes.



One proposed Prop H project is a solar power program where the City would contract for construction and installation of panels and provide affordable monthly financing to participating homeowners and businesses. Please join the Sierra Club, SFLCV, Greenpeace and the SF Chamber of Commerce in voting Yes on H.



Yes on I

Measure I will create a Municipal Utility District in San Francisco. Customers of California's 45 public power agencies enjoy rates that average 18% less than rates from private utilities like PG&E. The absence of profit margins and federal and state taxes, coupled with cheaper, municipal tax-free debt, results in clear savings to consumers served by public power agencies.

The Sacramento Municipal Utility District (SMUD) is currently the national leader in solar power. Please join the Sierra Club and Greenpeace in voting Yes on I. (The League of Conservation Voters has no position on this measure.)

Williams for City Attorney

The League of Conservation Voters urges you to vote for Steve Williams for City Attorney because he will fight to preserve and enhance open space, advocate for green-friendly policies, and safeguard our neighborhoods from environmental hazards.

Leal for Treasurer

Treasurer Susan Leal has maintained one of the state's highest investment yields for San Francisco. She instituted a socially responsible investment strategy, introduced the "one-stop" City Payment Center and cracked down on delinquent taxpayers.
