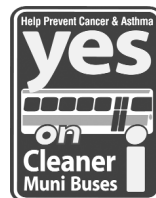

## Yes on I for cleaner Muni buses

Proposition I, on the March 2nd ballot gives MUNI what the SF Examiner calls a "kick in the pants" to finally phase out its oldest, highly polluting diesels that emit soot and 40 toxic chemicals that can cause serious illnesses including asthma and lung cancer. Proposition I requires Muni to replace the polluters with clean buses that meet the same anti-pollution standards as other city vehicles. ## Proposition 56: Yes ✓

## Proposition J: NO

Prop J is an 'end run' around neighborhood planning & public review. Prop J was developed without consulting with residents in the affected neighborhoods, their respective Supervisors, or even the City's own Planning Department. It throws away years of work by the City's Better Neighborhoods program to carefully re-zone and strengthen the historic eastern neighborhoods of the City.
