I believe climate change is the greatest issue of our time. As a climate justice advocate, I've dedicated my career to implementing local solutions to the global climate crisis. I've spent the past decade working for the City and County of San Francisco to implement cutting-edge environmental policies and programs that help the City reduce harmful greenhouse gas emissions while promoting greater equity and livability for all.

As lead Policy Coordinator at the SF Department of Environment, I worked collaboratively with legislators and community stakeholders to pass groundbreaking policies to ban natural gas in new municipal construction, reduce the use of plastic straws and other single-use disposable plastics, and prohibit harmful perfluorinated chemicals in disposable food service ware. I also worked directly with climate coalition activists to help pass a Board of Supervisors resolution declaring a Climate Emergency in San Francisco, pushing the City to accelerate local action to tackle the climate crisis.

I'm also a champion of renewable energy and proponent of public power. I currently work as the Clean Energy Communications Manager for the San Francisco Public Utilities Commission, where I lead marketing, education, and outreach campaigns for CleanPowerSF, San Francisco's community energy choice program serving over 380,000 residential and commercial customers with clean, affordable, and reliable energy. I also work everyday on the City's efforts to acquire PG&E's local grid assets so that we can expand public power to serve all of San Francisco. This is one of the single greatest actions we can take to help achieve the City's climate goals because it will allow us to use our clean electricity supply to promote greater transportation electrification and building decarbonization across our city.
